- 1. The name of the corporation is: Missouri Water and Wastewater Conference
2. The period of duration of the corporation is: Perpetual
3. The address of its initial Registered Office in the State of Missouri is: Robert S. Miller, 2211 Marilyn Drive, Jefferson City, Missouri 65101 and the name of its initial Registered Agent at said Address is: Robert S. Miller

- 4. The first Board of Directors shall be three in number, their names and addresses being as follows:

The purpose or purposes for which the corporation is organized are: The Corporation is organized to advance the fundamental and practical knowledge of the collection, treatment and distribution of water for the public water supply. To advance the knowledge of the nature, collection, treatment and disposal of sewage and industrial wastes. In addition, the Corporation will advance the practical and fundamental knowledge of the design, construction, operation and management of water and sewage treatment facilities.

The Corporation will work for the improved sanitation of waterways. The Corporation will support and further the activities of individuals and organizations whose aims are to improve the water supply, safely and efficiently dispose of sewage, and improve the health and sanitation within the state of Missouri.

The Corporation is authorized to own real and personal property, to borrow funds, pledge, mortgage and encumber property, and to do all other things authorized by law.
